4. That as rectified as aforesaid, the Trust Deed dated 28.01.2011 shall remain in full force and effect.
5. That the other clauses and contents of the remaining portion of the Trust Deed dated 28.01.2011, registered as Document No. 514/2010-11, and the Deed of Amendment to the Trust Deed dated 08.12.2014, registered as Document No. 488/2014/15, remain as same.

NOW THIS AMENDEDMENT DEED WITNESSETH that in exercise of the power on that behalf and of every other powers therein enabling the Continuing Trustees confirm the relieving of Mr. Venkataraman Sriraman from the Trust.
