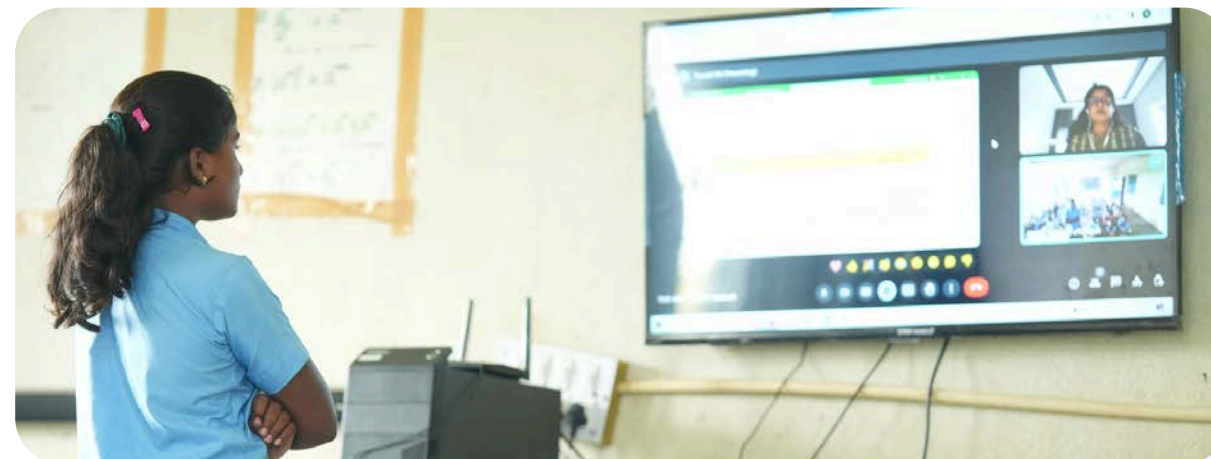






# Our Solution

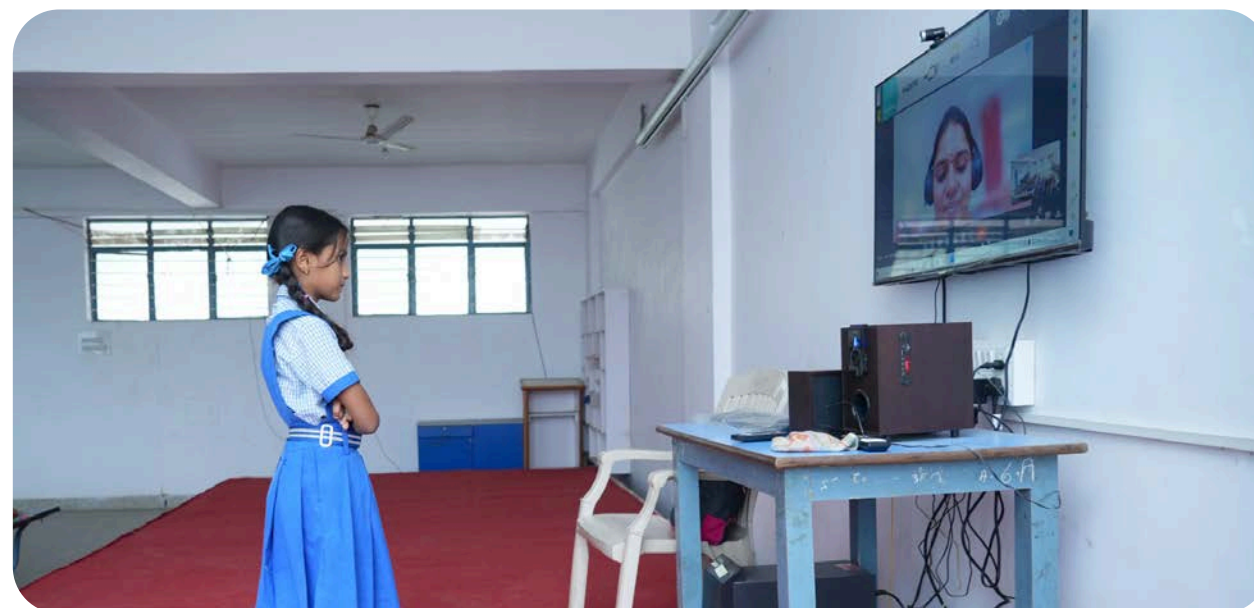




# The Digital Classroom Program

**eVidyaloka's Digital Classroom Program is at the heart of our mission to provide quality education to children in rural India.**

By connecting Volunteer Teachers from across the globe to classrooms in remote villages, we bring subject expertise and interactive learning to students who would otherwise face educational barriers.



Through live, online sessions, students are introduced to subjects like Math, Science, and English and Artificial Intelligence in a structured and engaging manner.

The Digital Classroom Program employs Class Assistants who act as the extended arm of the Volunteer Teachers and ensure smooth functioning of the classes on the ground, ensuring students learn.



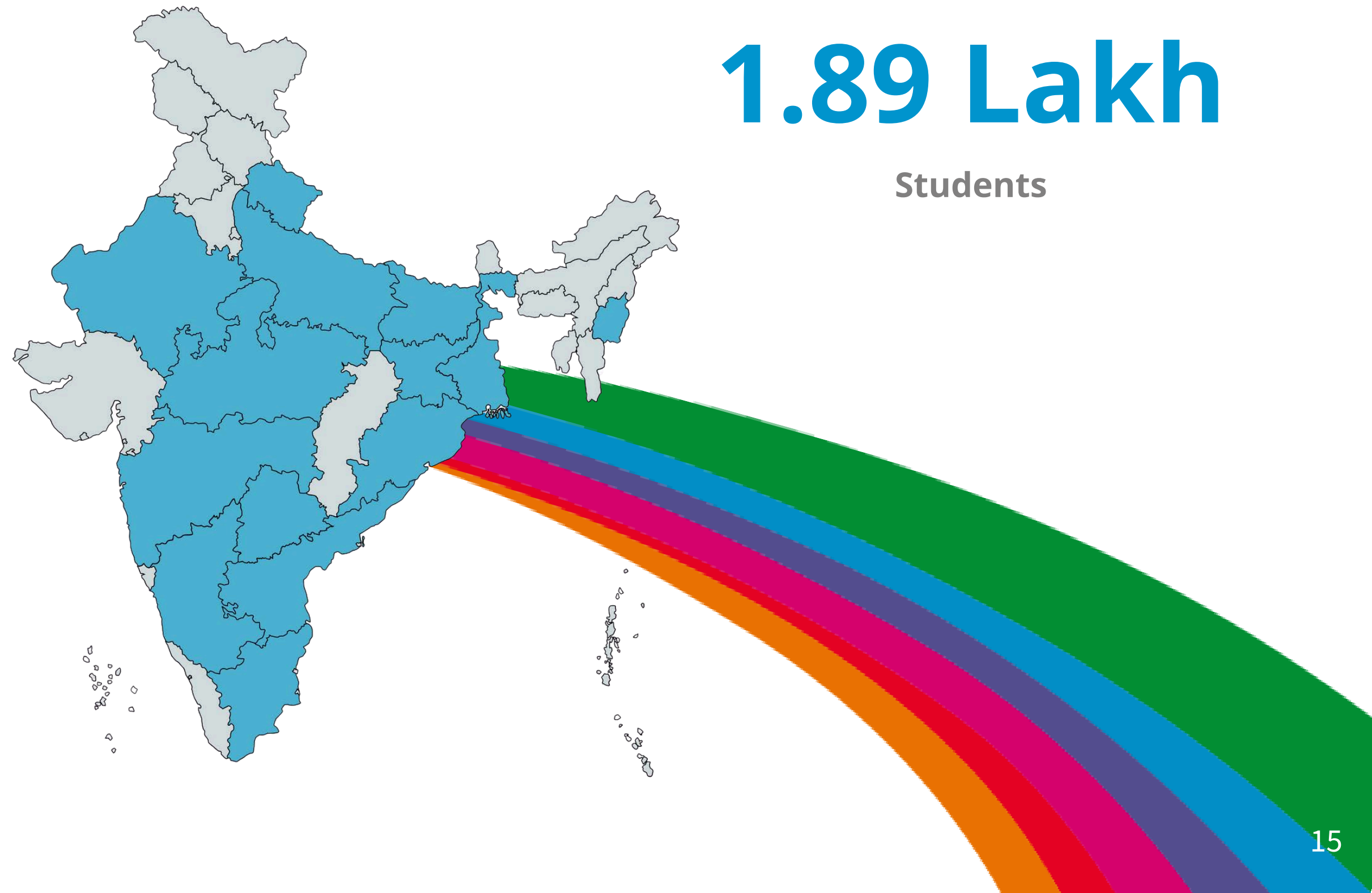

# The Digital Classroom Program

Since its inception in 2011, eVidyaloka has been delivering online classes in Science, Math, and English through its Digital Classroom Program, supported by dedicated Volunteer Teachers from around the world. These classes have opened up educational opportunities for students in rural India by providing quality instruction from passionate educators.

In addition to core subjects, eVidyaloka is committed to broadening students' horizons through co-scholastic activities and innovative initiatives. With the Digital Classrooms installed in their schools, students not only excel in their academic curriculum but also get to apply their knowledge through hands-on projects, collaborate with urban peers, and develop vital leadership and soft skills. Through exposure to Artificial Intelligence and modern-day skills, these students gain experiences that make them more aware of the world and prepare them for the future.

# National Students Innovation Challenge (NSIC)

The National Students Innovation Challenge (NSIC) is an initiative aimed at fostering creative thinking and promoting Social Emotional Learning among students by addressing the United Nations Sustainable Development Goals (UNSDGs). This unique online event brings together students from rural and urban backgrounds to collaborate and develop innovative solutions for a better tomorrow. This is executed through the Digital Classroom Program.



NSIC Season 7, held with the support of LTI Mindtree Foundation, during 2023-24, unfolded over 4.5 months in two phases. After launching on July 15th, 2023, more than 900 students from across India registered to participate. In Phase 1, students, guided by volunteer mentors, spent two months working on problem statements corresponding to the UNSDGs. Through thorough research and analysis, these students presented their solutions to an eminent jury panel, which shortlisted teams with the most promising ideas.





# National Students Innovation Challenge (NSIC)



In Phase 2, shortlisted teams were paired based on shared themes and goals. Over 4-5 weeks, they combined their independent solutions into unified proposals. The grand finale of NSIC Season 7 was held at the LTIMindtree campus in Bengaluru, where 80 students from 20 top teams presented their final solutions.



Of these, 8 teams were recognized for their outstanding contributions, each earning a cash prize of INR.15,000. Through their participation, these students emerged as changemakers, showcasing the power of collaboration and innovation in addressing global challenges.







# National Students Innovation Challenge (NSIC)

At the NSIC award ceremony, Anand Sri Ganesh, CEO of NSRCEL, IIM Bengaluru, emphasized three critical aspects of success: initiative, the belief in an idea strong enough to bring it to life beyond textbook learning; implementation, the practical execution of that idea; and influence, the capacity to create change and improve communities.

Ramesh Revuru, VP and Global Head, Low Code Unit at LTIMindtree, further highlighted the significance of the event, stating that "NSIC serves as a testament to the power of education in nurturing future leaders who are ready to tackle the world's challenges head-on."







# Build Rural Artificial Intelligence Network(BRAIN)

In 2023-24, the 'Build Rural Artificial Intelligence Network' (BRAIN) project was piloted by eVidyaloka in collaboration with Microsoft. The initiative aims to introduce artificial intelligence to students in 300 rural government schools across seven Indian states: Tamil Nadu, Karnataka, Andhra Pradesh, Telangana, Uttar Pradesh, Uttarakhand, and Bihar. Through this program, 300,000 students will gain access to essential AI knowledge, empowering them with new-age technological skills. This is executed through the Digital Classroom Program.



The course offers simplified video content in four regional languages—Tamil, Telugu, Kannada, and Hindi—making it accessible to a diverse student base. Students participate in one-hour video sessions weekly, supplemented by live sessions led by Microsoft employees who volunteer to explain AI concepts in a practical and engaging manner. Aligned with the Government of India's "Responsible AI for Youth 2022" program, BRAIN is designed to foster digital literacy and prepare students for future technological advancements.



# Build Rural Artificial Intelligence Network(BRAIN)



A contest was conducted, encouraging students to apply their learning about Artificial Intelligence to solve problems around them and to present their solutions in the form of projects.



The ideas that came up were mind boggling. Students developed solutions to prevent tigers from entering their villages, flood alert systems, theft detection systems and more.



They applied the learning to everyday problems they face in their day to day life.

Some of these projects were displayed at eVidyaloka's annual flagship event RUBARU and the students presented their projects on stage, surprising most of the audience, with their original ideas.

The pilot phase has laid the foundation for scaling up and refining this innovative educational approach, setting the stage for a broader impact on rural education.

# Empowering Dreams through Goal-setting Effectively(EDGE)

Empowering Dreams through Goal-setting Effectively (EDGE) is a transformative program designed to cultivate student leadership skills and empower young learners to set and achieve their personal and community-oriented goals. Recognising that leadership is essential for personal and academic growth, EDGE equips students with the tools and strategies necessary to influence, motivate, and guide themselves and their peers toward success. This is executed through the Digital Classroom Program.

Through a child-specific approach, the program encompasses three distinct phases: the Introduction Phase, where students engage in hands-on activities to develop 21st-century leadership skills; the Plan It All Phase, where they learn to set meaningful goals and create actionable plans; and the Level Up Phase, which emphasises the execution of their plans in real-world scenarios. Spanning six months, EDGE provides a comprehensive curriculum that addresses key aspects of leadership, including self-awareness, communication, teamwork, critical thinking, and problem-solving.

Ultimately, EDGE aims to empower students not only to envision their dreams but also to take concrete steps toward realizing them, thereby fostering a new generation of effective leaders.



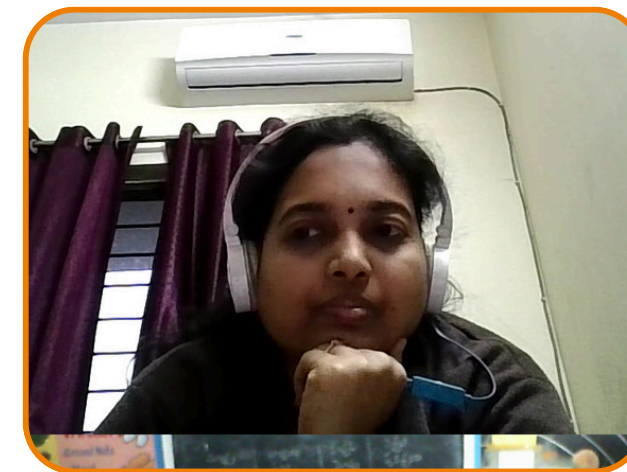

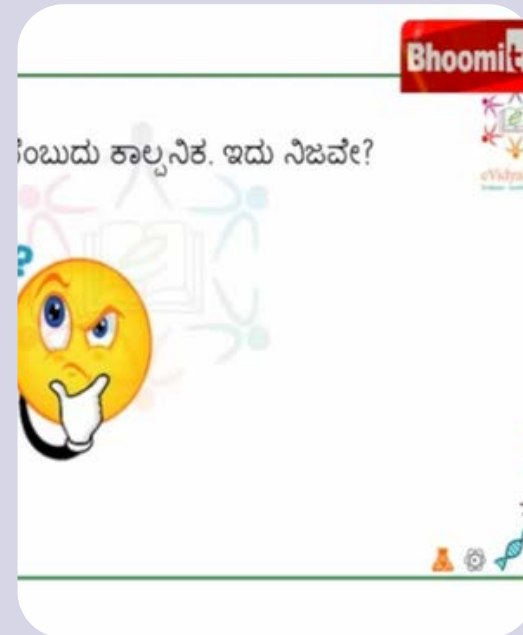




# Teach Through Television Program

To reach students unable to access our digital classrooms, we launched the "Teach Through Television" program, which delivers curated video lessons in regional languages through local cable channels. This initiative provides an accessible medium for students not enrolled in our programs, allowing them to benefit from quality educational content from the comfort of their homes.

By leveraging television, we extended our reach to a broader audience, ensuring that more children in rural areas had the opportunity to learn.



With the support of Volunteer Teachers and Subject Matter Experts, we identified and developed resources that could effectively support virtual learning for these students. The video lessons, structured around the 5E pedagogy of teaching and learning, were designed to be grade-level appropriate and engaging.

Through this program, we ensured that students received comprehensive lessons that promote understanding and retention, aligning with our goal to provide quality education through innovative and accessible platforms.

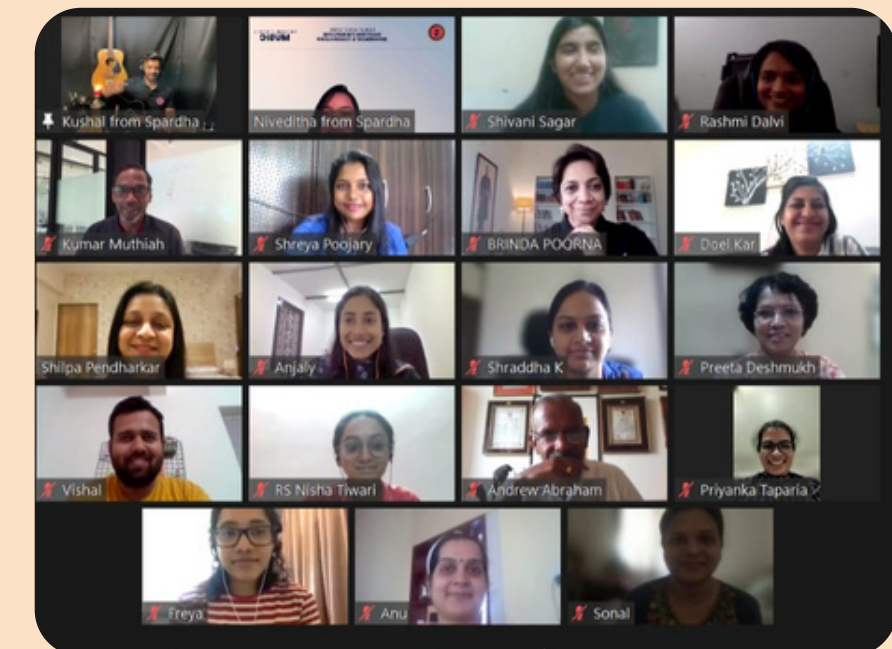
# Our Volunteer Teachers

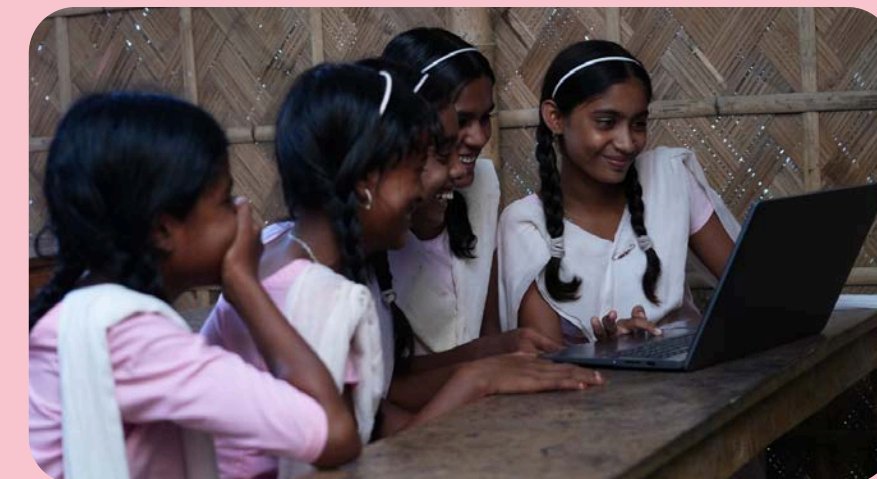
## BRAIN

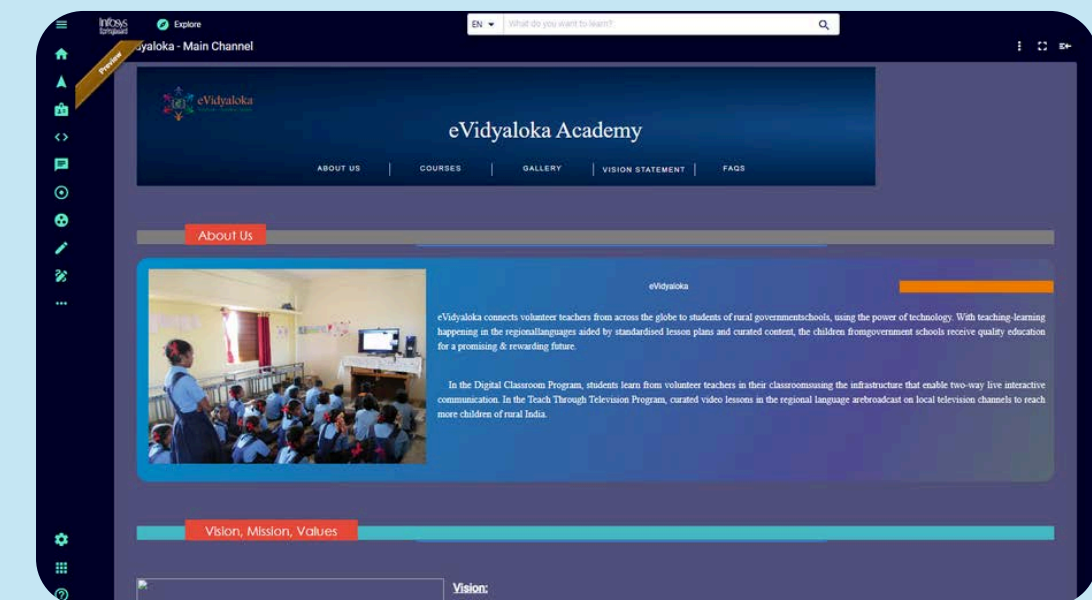
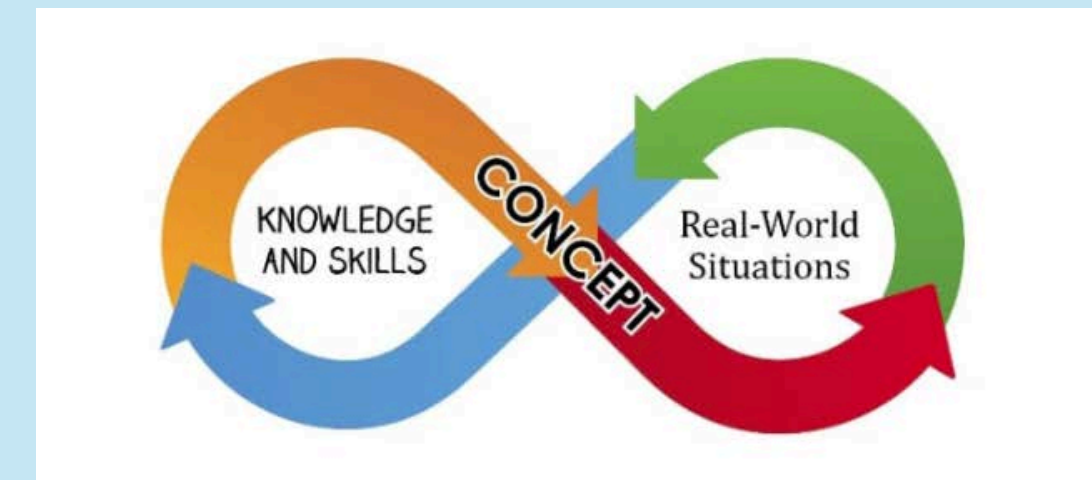




# Academics and Content

The Academics function at eVidyaloka is dedicated to establishing a strong foundation for quality education, focusing on bridging gaps in conceptual knowledge among students. In AY 23-24, the program identified challenges in English, Maths, and Science learning and shifted from textbook-based methods to a more conceptual approach.

To address these gaps, eVidyaloka undertook three significant projects funded by Infosys Foundation, LTIMF, and Microsoft, focusing on developing STEM-aligned content for several states, including Madhya Pradesh, Rajasthan, and Uttar Pradesh. With over 1,000 customized learning resources created, the goal is to enhance student engagement and understanding. Additionally, eVidyaloka's content featured on the Infosys Foundation's Springboard platform as a content repository for Maths, Science, and English. This initiative provided supplementary educational resources and guided Volunteer Teacher to enhance their teaching strategies, ultimately enriching the overall learning experience for students.

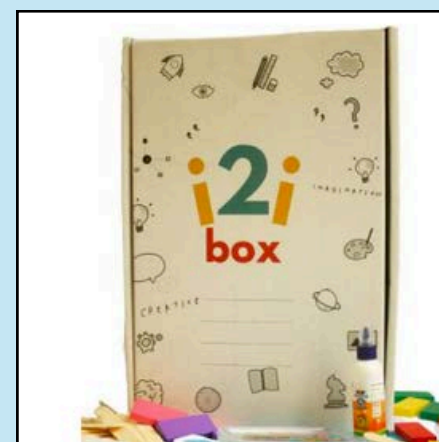
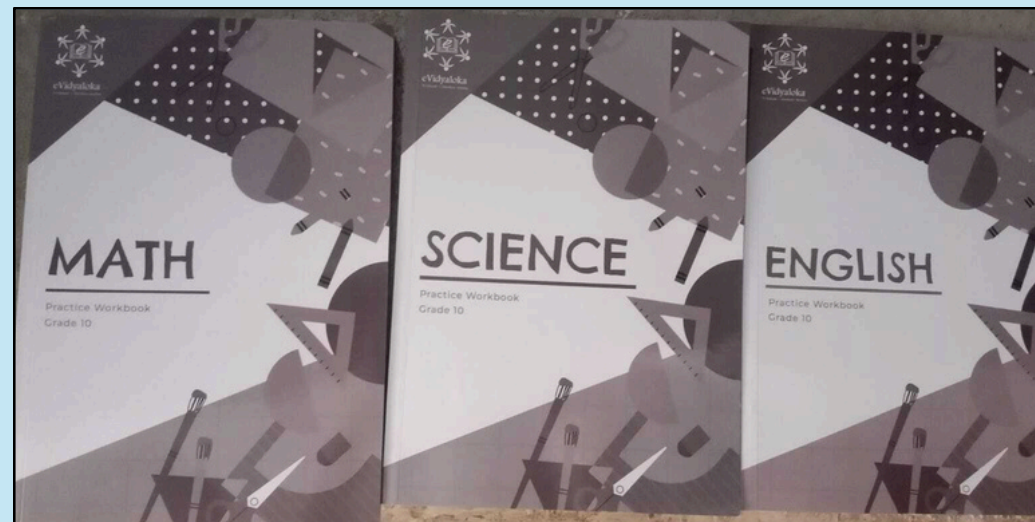






# Academics and Content

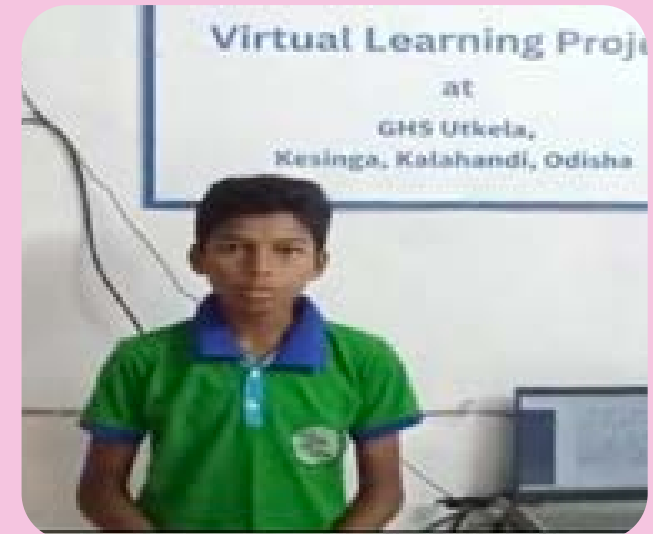




## Stories of Change

Ankush lost his father in 2012, leaving his mother unable to afford extra tuition fees despite his eagerness to learn. eVidyaloka's virtual program has provided him with a valuable opportunity, enabling him to regularly attend online math classes that have significantly improved his skills.

Through the EDGE program, he has learned to set short-term and long-term goals, enhancing his student life. His dedication paid off when he participated in the National Means cum-Merit Scholarship (NMMS) of Odisha and successfully secured selection.



Vintipura, a farming village in Dholpur district of Rajasthan, lies about 40 kilometers from the Taj Mahal, accessible by a single small road. It serves as a hub for nearby villages, including Khupra, located 4 kilometers away. In a region troubled by crime, quality education is essential for a brighter future. Saurav, a student from Khupra, walks to Vintipura each day to attend school.

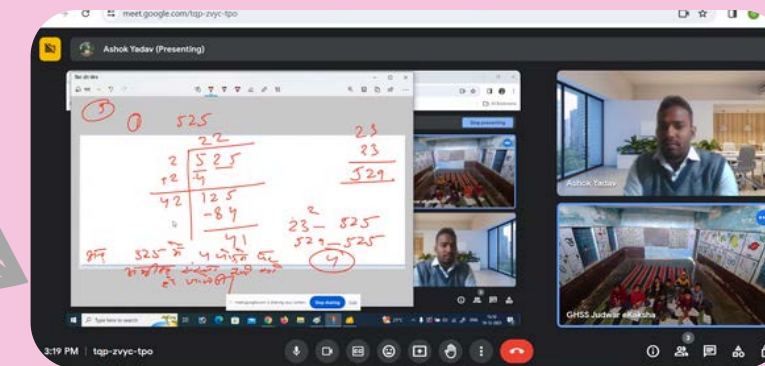
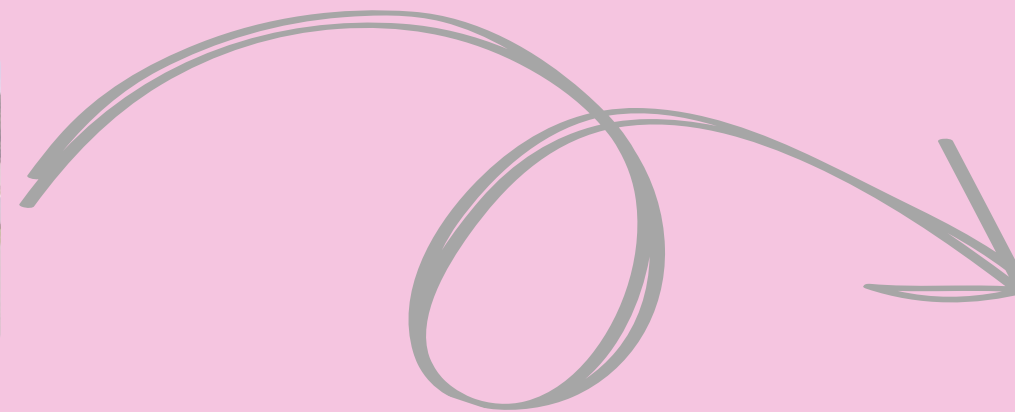


## Stories of Change

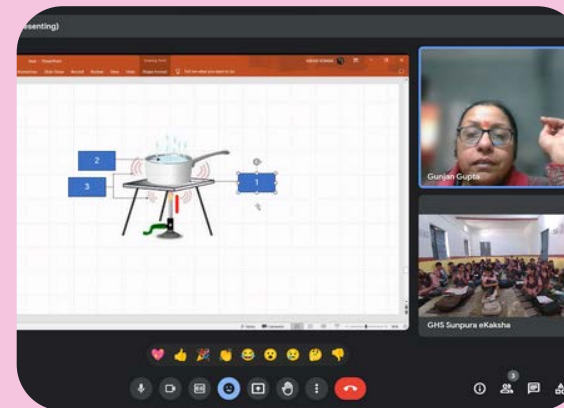


# Stories of Change

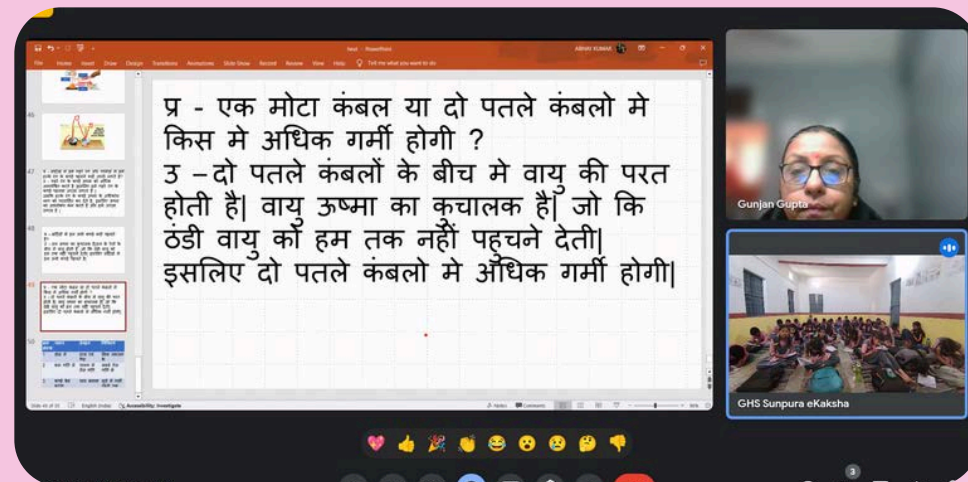

This is the story of Nagina Khatoon, a young girl who faced significant challenges in her pursuit of education. Throughout the year, she attended school for only 7 to 8 days. Initially, Doli, the Class Assistant of the eVidyaloka classroom at UHS Charghara, in Giridih District, Jharkhand, thought this was typical behavior for a child. However, her perspective changed when she visited Nagina's home.

There, Doli learned that Nagina's mother had passed away eight months prior, and shortly after, her father remarried. Unfortunately, her new stepmother treated her harshly, often making Nagina feel like a servant in her own home. During the visit, her stepmother scolded her upon seeing Doli, highlighting the difficult situation Nagina faced.

Determined to help, Doli spoke with her stepmother about the importance of education. She explained how the program offered online classes and emphasized the value of girls receiving an education. After some discussion, Nagina's father agreed to let her attend school, and she was filled with joy and excitement at the opportunity.

Doli also invited her parents to the upcoming Parent-Teacher Meeting, fostering a sense of community and support. This positive engagement made Doli's future home visits easier, and now, she receives respect from both parents and students during her visits.







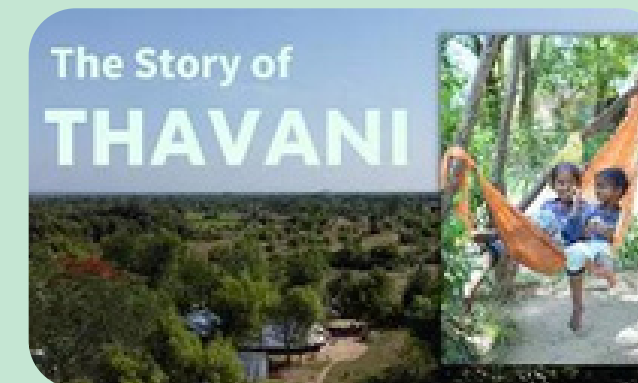

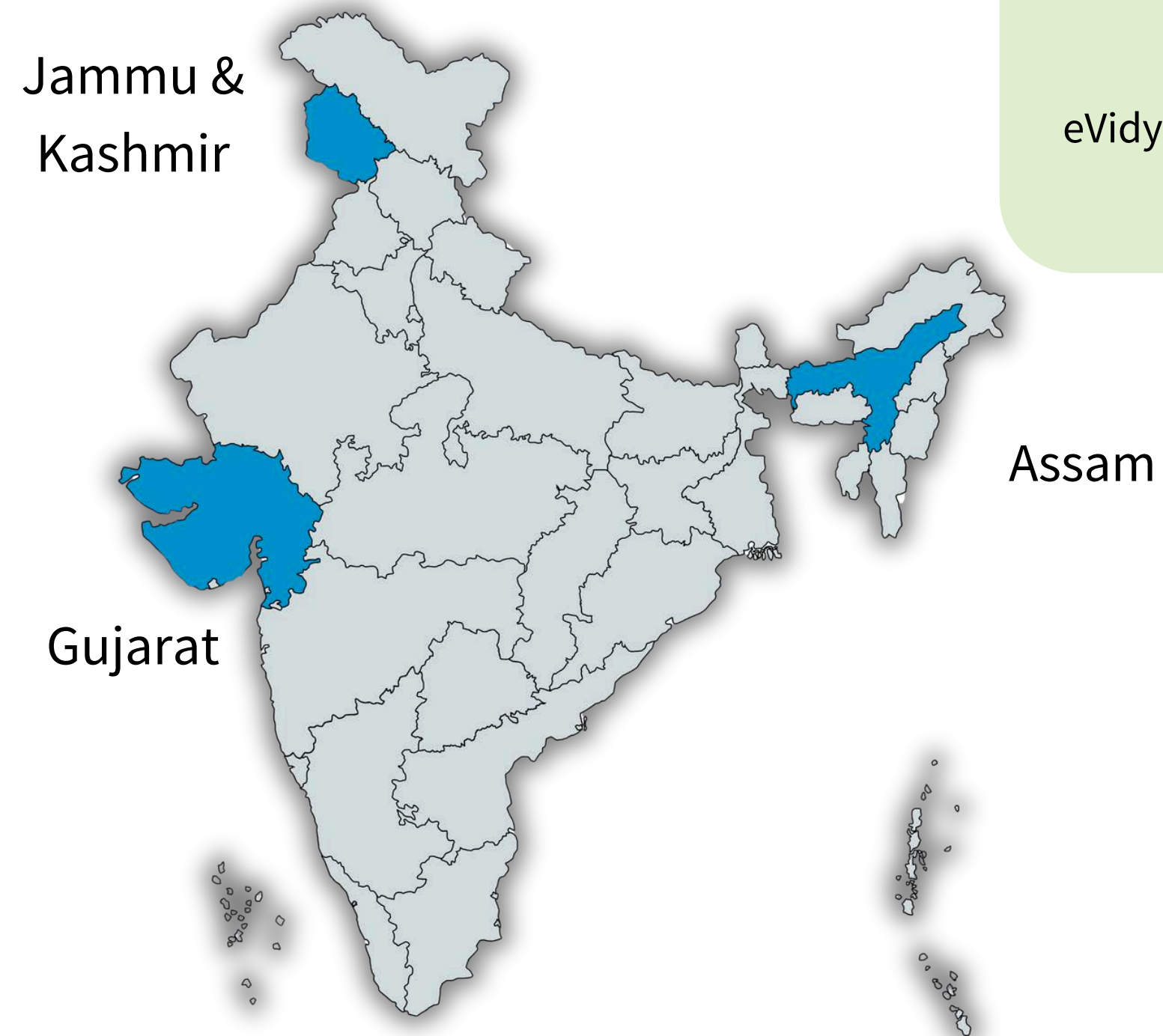

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Trust to cease to continue as a going concern.

(d) Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.


